REGISTRATION FEE TERMS INCOMING FRESHMEN/TRANSFER STUDENT: LETTERS OF ACCEPTANCE ARE MAILED MARCH 6, 2016. THE REGISTRATION FEE IS DUE MARCH 31, 2016. THIS FEE IS ACCEPTED IN GOOD FAITH THAT THE STUDENT IS ELIGIBLE TO RECEIVE A COURSE SELECTION FORM AND WILL BE ATTENDING SCHOOL IN THE FALL OF 2016. IF AN INCOMING FRESHMAN/TRANSFER STUDENT MAKES HIMSELF/HERSELF INELIGIBLE, THE FEE REMAINS NON-REFUNDABLE. PAYMENT OF THE REGISTRATION FEE SECURES THE STUDENT'S COURSE SCHEDULE AND ROSTER PLACEMENT UNTIL MAY 31, 2016. TUITION TERMS 1. FRESHMEN/TRANSFER STUDENTS: TO SECURE A PLACE IN THE CLASS, THE TUITION CONTRACT MUST BE COMPLETED AND RETURNED WITH A TUITION DEPOSIT OF \$500 BY MARCH 31, 2016; THIS PAYMENT IS CREDITED TO 2016-2017 TUITION AND IS NON-REFUNDABLE. TUITION FOR ALL STUDENTS FOR THE ENTIRE SCHOOL YEAR IS DUE BY MAY 31, 2016 (THE "TUITION DEADLINE") OR WITHIN 10 BUSINESS DAYS FROM THE DATE THE STUDENT IS ENROLLED. FAILURE TO MEET THE TUITION DEADLINE, BY PAYMENT IN FULL OR SIGNED AND SUBMITTED TUITION LOAN/ACH DEBIT WITH THE APPROVED LENDING INSTITUTIONS/COMPANY WILL RESULT IN THE DELETION OF THE STUDENT'S COURSE SCHEDULE. SCHEDULES FOR STUDENTS WITHOUT CURRENT PAYMENT ON TUITION LOANS/ACH DEBITS PRIOR TO THE START OF SCHOOL WILL ALSO BE DROPPED.
